Policy Scope

This policy applies to all University stakeholders, including students, faculty, staff, Alumni ,contractors, partners, and affiliated entities. It covers sustainability integration across institutional governance, operations, education, research, community engagement, and health and wellbeing.

Policy Statement/ Definitions/Procedures

Institutional Sustainability Framework

Alfaisal University implements sustainability across five core institutional sustainability areas:

Education

4.	Faculty & Researchers	Integrate sustainability into teaching, research, and innovation activities.
5.	Students & Staff	Participate in sustainability initiatives and support sustainable practices in daily activities.

Monitoring, and Reporting.

The University will:

- Monitor sustainability performance indicators across operational, academic, and engagement areas.
- Track progress toward institutional sustainability and climate objectives.
- Measure and monitor greenhouse gas (GHG) emissions in alignment with internationally recognized standards, including the Greenhouse Gas (GHG) Protocol, where applicable.
- Report sustainability performance through institutional and external reporting frameworks where applicable.
- Maintain transparency through regular sustainability disclosures and reporting.

Sustainability in Funding and Resource Allocation

The University will support sustainability through:

- Responsible and sustainable investment practices.
- Funding sustainability research and innovation initiatives.
- Supporting student sustainability projects.
- Investing in sustainable infrastructure and technologies
